***Free Speech Area Usage***

In accordance with Board Rule 9902, the right to exercise free discussion area is hereby designated as follows:

- A. Bounded in the north face of the E3 building, at the west corner

In accordance with College policy, the use of any sound equipment shall be prohibited in the Free Speech area.

The right to exercise free speech shall take place in the location described above only. The college has the responsibility to designate time, place, and manner. The free speech area will be available during regular business hours. The notification for the above shall be submitted to the Student Activities Office, building F5-212 (Campus Center)

**Board Rule 9902, Student and Student Faculty Discussion Area:**

1. Such discussion shall not interfere with or disrupt the educational program if the College, and ...
2. Except the expression which is obscene, libelous, or slanderous according to current legal standards or which so entices students as to create a clear and present danger of the commission of unlawful acts on Community College premises, or the violation of Community College regulations or the substantial disruption of the orderly operation of the Community College, shall be prohibited.

**Board Rule 9902.12, Forms of Speech**

- C. No person using the Free Speech Area shall solicit donations of money, through direct requests for funds, sales of tickets or otherwise, except where he/she is using the Free Speech Area on behalf of and collecting funds for an organization which is registered with the secretary of state as a nonprofit corporation, or is an approved Associated Student Organization or Club.
