

FAFSA Application Deadlines

The Free Application for Federal Student Aid (FAFSA) is the federal application for financial aid. This application is also used to apply for aid from other sources, such as state and school.

FAFSA application processes:

1. Complete the FAFSA application on-line at www.fafsa.gov
2. List East Los Angeles College's institution code: **001222**
3. After the FAFSA is submitted on-line, it may take anywhere between 3 to 15 days for the your information to show up on your student portal. If you do not receive a financial aid notification indicates that we receive your FAFSA information, please check with the Financial Aid & Scholarship Office. There maybe a chance that your name and/or Social Security Number are mismatched between your FAFSA and school record.
4. Therefore, it is to your advantage to apply as early as possible to meet the application deadline, we must have all of your documents by the last day of your enrollment period; we recommend that you do not go beyond the date listed below to submit your application.

California Dream Act Application Deadlines

The California Dream Act Application for State funds is the state application for financial aid for Dreamer or DACA students. This application is used to apply for state aid such as California College Promise Grant (CCPG) (Fee Waiver), **the following Grants have a deadline of March 2, 2019), Cal Grant, Student Success Completion Grant (SSCG)*** or other resources from the state.

California Dream Act application processes:

1. Complete the California Dream Act application on-line at <http://dream.csac.ca.gov>
2. East Los Angeles College's institution code: **02226000**
3. After the Dream Act Application is submitted on-line, it may take anywhere between 3 to 15 days your information to display in your school portal. If you do not receive notice of award of California College Promise Grant(CCPG) and you believe you should be eligible, please visit the Financial Aid & Scholarship Office to check on the status. There may be a chance that your name and/or address are mismatched between your Dream Act Application and your school record.
4. Therefore, it is to your advantage to apply as early as possible to meet the application deadline, we must have all of your documents by the last day of your enrollment period; we recommend that you do not go beyond the date listed below to submit your application.

*To be eligible for SSCG, you MUST be a Cal Grant recipient and enroll in twelve (12) or more units per term in order to be considered for this grants.

The Cal Grant is a state funded program which provides funding to help pay for tuition/fess at qualify institutions offering baccalaureate degree programs. To apply for the Cal Grant, **both** Cal Grant GPA Verification form **and** FAFSA or Dream Act application must be complete by the deadline date.

Note:

Campus will submit GPA record to California Student Aid Commission (CSAC) for those students:

- Had active enrollment status within the last 365 prior to the application deadline
- Completed 16 to 24 units within LACCD
