1098-T Form Information

A 1098-T form is issued to eligible students who paid out-of-pocket "qualified educational expenses" in the preceding tax year.

- Qualified expenses include enrollment and tuition fees only.
- Students who received California College Promise Grant (CCPG), previously known as BOG Fee Waiver, to cover enrollment fees do not qualify for 1098-T forms.

Your 1098-T form is mailed to the permanent address on file with the Admissions & Records (A&R) Office as of the date the forms are printed (late January).

- Students with incorrect SSN/TIN on file with the A&R Office will not receive 1098-T forms.
- Students can update SSN/TIN and permanent addresses by contacting the A&R Office. Please notify the Business Office once the information is updated.
- 1098-T forms are not generated for international students if they do not have valid United States addresses on file.
- Students will have until <u>March 17, 2025</u> to update SSN/TIN and request 1098-T forms for 2024 fiscal year.


